The study was initiated to ensure maximum transportation efficiency and reduce costs. By adjusting bell times at some schools, buses can potentially service more students to more schools with fewer vehicles.

Grade 9 Math students have completed or are completing their EQAO testing.Exams for all secondary students began this week. She thanked staff for their role in preparing students throughout their educational preparation.

Director O'Brien highlighted a few upcoming Board-wide celebrations including: **Bell Let's Talk Day, January 25, 2017** - She noted that the Board supports this national initiative as an opportunity to encourage students and families to talk more about mental health and understand the importance of recognizing when to seek help. **Black History Month in February –** Director O'Brien indicated that schools have great activities planned with special guest speakers, African dance lessons, and many exciting activities to enrich our students' knowledge of black history.

Superintendent of Education, Tracy Barill, provided a detailed review on the background information brought to Board over the past year. She noted that recommendations were derived based on the findings of an extensive public consultation process and a formal Working Committee which consisted of parents, staff, and student representatives. Superintendent Barill and Lewis Morgulis, Manager of Planning and Admission, gave an overview of the Long Term Accommodation Plan, Aims of the Study, Background Data, Existing Boundaries, Process Followed, Range of Options and Recommended Options. Discussion ensued. Trustee Chapman asked for clarification regarding the data pertaining to enrolment projections as it relates to the boundary review and its effect on the Whitby secondary schools. Mr. Morgulis advised that numbers were obtained from various planning processes and input from the Town of Whitby. Trustee Chapman inquired whether only St Matthew and St. Theresa Catholic schools would be affected by the boundary review to which Mr. Morgulis confirmed that it was only the two schools. Trustee Corless asked if the changes pertaining to the French Immersion program could be done at an earlier date. Director O'Brien advised that the date projected was due to consideration of the size of cohort but the date would be part of our boundary review process.

I would also like to share part of what His Holiness, Pope Francis shared regarding the Christian belief in the Resurrection of Christ and in our own resurrection in his message to the pilgrims in the Vatican's Paul VI hall on February 2, 2017:

We all have a little fear of the uncertainty of death. Each time we face our death, or that of a loved one, we feel that our faith is tested. All our doubts emerge, all our weaknesses and we ask ourselves: But really there is life after death ... I can still see and embrace the people I loved...?

However, despite the fears and concerns of the community, St. Paul invites the people to hold firm to "the hope of salvation," especially "in trials and in the most difficult moments of our lives."

Christian hope is not like the everyday hopes we have, like when we hope or wish for good weather, even though we know that the weather may actually be bad.

Rather, Christian hope means to be sure that I'm on the way to something that is, not that I want to be. We should strive to live in this kind of hopeful expectation, using the image of a pregnant woman who waits in expectation to see her child.

Although this isn't always easy, we are able to learn to live with this kind of expectation that to do this requires a "humble heart, a poor heart. Someone who is full of himself and of his possessions, on the other hand, cannot place his trust in anyone but himself.

Something that touches his heart and fills him with hope, is the line from St. Paul that says: "And we shall always be with the Lord."

One nice thing: everything passes but, after death, we shall be forever with the Lord. It is the total certainty of hope.

St. Paul writes that Jesus died for us so that whether we wake or sleep, we should live together with him. These words, are always a source of great consolation and peace.

C. <u>BUSINESS</u>

c.1 <u>Ministry of Education Correspondence</u>

R. Putnam provided a brief summary of the Ministry correspondence regarding the School Year Calendar dated December 2, 2016.

c.2 System Stakeholder Survey Results

The results of the System Stakeholder Survey were provided to the Committee with respect to the placement of a PA Day on August 31, 2017 and a Board Designated Holiday on March 9, 2018 with 85% of respondents in favour of the proposed dates.

c.3 <u>Draft Elementary/Secondary Calendars</u>

• March Break

The Committee supported the system stakeholder survey results. March Break to be scheduled from March 9, 2018 to March 16, 2018 with a PA Day on August 31, 2017.

• PA Day Placement

Superintendents Putnam, Mullins and O'Reilly reviewed the proposed placement of PA Days in relation to Ministry requirements, collective agreement obligations and the student achievement cycle. It was noted that 6 of 7 PA Days were Board wide (both panels). The Committee inquired about the number of common days with the DDSB and implications of not aligning PA Days. Superintendent Putnam advised that there were cost implications from a transportation perspective. DCDSB has been in discussion with DDSB regarding the possible alignment of the April 27 (DCDSB) and May 4 (DDSB) PA Day dates. Superintendent Putnam to follow up with DDSB.

The Committee recognized the legacy rationale behind not placing PA Days on the Friday before a holiday Monday in order to maximize the number of long weekends for student well being and to maximize professional learning in accordance with student achievement cycles. The Committee inquired as to whether staff would consider placing one PA Day on a Friday before a holiday Monday (preference would be the Family Day weekend) in order to reduce the number of incongruent days with DDSB. Superintendent Putnam indicated he would bring the request forward to Administrative Council for consideration and further discussion.

L. Dodson inquired about whether the potential change of PA Day placement would require changing the focus of the day. Staff advised that content would be the same in order to meet Ministry expectations and balance professional learning.

• Reporting Dates (Elementary)

Superintendents Putnam and O'Reilly noted that Reporting/Assessment/Evaluation dates are scheduled in October and January in accordance with Growing Success.

• Exam Days Placement (Secondary)

Superintendent Putnam indicated that the placement of Exam Days allows for balanced semesters with 89 and 88 instructional days respectively.

• Turnaround Days (Secondary)

Superintendents Putnam and Mullins confirmed that Turnaround Days have been placed on January 31, 2018 and June 27, 2018 at the end of each semester for students to review their exams and for teachers to provide credit rescue opportunities.

Trustee Corless inquired as to whether two Turnaround Days at the end of the school year would be possible to allow teachers and parents more time to prepare for the graduation ceremonies. Superintendent Mullins advised that the fifth day of exams is a conflict day and can be utilized for this purpose in addition to the Turnaround Day and two end of year PA Days.

c.4 Approval Process and System Communication

Superintendent Putnam indicated that feedback from the Committee would be reviewed with Administrative Council on February 21st with the final staff proposed calendars being presented to the Board of Trustees for approval on February 27, 2017.

RATIONALE

Staff is recommending the attached calendars for elementary and secondary schools for the upcoming 2017/2018 school year. The proposed calendars are based on input received from Administrative Council, system stakeholders and the School Year Calendar Committee. The calendars presented are compliant with legislative requirements as outlined by the Ministry of Education. Of the seven PA days three must be dedicated to provincial education priorities (as denoted with an asterisk in the attached calendars). Within the attached calendars it is proposed that the first day of student instruction occur on Tuesday, September 5, 2017 following Labour Day. In addition, the proposed calendars require a PA Day for both panels prior to the start of the school year on Thursday, August 31, 2017 to accommodate a Board designated holiday prior to the March break. As a result, the proposed calendars are considered modified calendars. Having a PA Day prior to Labour Day will allow for effective and coordinated School Improvement Planning for the upcoming school year. Also of note is that secondary school exams in both semesters will be followed by an instructional day to provide opportunities for student review of their course and exam assessments consistent with the principles of the Ministry's Growing Success document. Following Board approval the calendars will be submitted to the Ministry of Education for final review and approval in accordance with mandated timelines and legislated requirements.

RATIONALE

School Improvement Planning

As part of the School Improvement planning process, the principal and Student Achievement Team were encouraged to work collaboratively with members of their Safe Schools Team to integrate the school improvement goals in the Catholic Community Culture and Caring Pillar with the goals of the school's Bullying Prevention Plan and the Mental Health Action Plan. Evidence from school monitoring visits demonstrated that schools are setting high, but achievable goals to ensure that students feel safe, welcome and valued at school.

Safe and Caring Schools Bullying Prevention Initiatives

Our Safe and Caring Schools theme for 2016-2017 is directly linked to our year-long theme of "Community" and the Catholic Education Week theme of *Walking Forward Together*. We acknowledge that it takes every member of the school community to work together to create safe and caring school communities.

Each year, the Durham Catholic District School Board designates two Safe and Caring Schools weeks focused on bullying prevention - one in November and one in February. The Safe Schools Committee provided Prayers, Announcements and talking points focused on the theme of *Walking Forward Together* for each day in these two weeks. The announcements and prayers helped the schools focus on a positive and proactive approach to developing healthy relationships among students. All classroom teachers

are expected to complete the five mandatory lessons in K-12 Bullying Prevention Curriculum between the week in November and the week in February.

We also continue to utilize our Pink Shirt slogan "Kindness is my Superpower". As part of the November Bullying prevention activities, students across the Board were invited to submit multi-media presentations that demonstrated the "Kindness is My Superpower". There were many impressive submissions which were narrowed down to two pieces of visual art – from a Grade 4 student at St. John Bosco C.S. and a Grade 12 student at St. Mary C.S.S. There were also three video winners – the Grade 8 class at St. Thomas Aquinas C.S., a Grade 12 Media Arts class at St. Mary C.S.S. and a Grade 12 Mathematics class at Archbishop Denis O'Connor C.H.S. The winning submissions were posted on the Board website throughout the month of February.

During the February Stand Up to Bullying Week all schools were expected to hold at least one school wide event to draw attention to bullying prevention. All schools in the Board participated in International Stand Up to Bullying Day on February 22, 2017 by wearing pink shirts. Almost 3000 members of our school communities wore our Kindness is My Superpower t-shirt. The day was captured on Twitter using the hashtag #DCDSBgetpink.

Police/Board Protocol

In September 2015, the Ministry of Education released the revised Police/Board protocol to be implemented in September 2016. During Safe and Caring Schools Week in September, all administrators and senior teachers/teachers-in-charge were provided with a half day inservice to address the changes. During the month of October, all staff were given updates on the revisions during a staff meeting using a Power Point presentation prepared by the Safe Schools Department.

Revision to Policy and Procedures

The changes to the Police/Board protocol meant that changes had to be made to some of our Emergency Preparedness procedures. As such, all of the procedures that flow from the Emergency Preparedness Policy are being reviewed and revised as needed. The Lockdown and Hold and Secure Procedure, and the Bomb Threat Response Procedure were revised first in keeping with the implementation schedule of the Police/Board protocol. Members of the Emergency Preparedness Committee continue to work on the revisions to the remaining Emergency Response procedures.

The Student Discipline Policy and Procedure were revised this year to ensure that they continue to be consistent with the Ministry of Education policies on Student Discipline.

System-Level Training

Violent Threat Risk Assessment:

This year, our in-house VTRA trainers successfully trained over 80 staff and community members in Level One Violent Risk Threat Assessment and Kevin Cameron from The Canadian Centre for Threat Assessment and Trauma Response provided the Level Two training for the same group. Continued training in VTRA ensures that we have many staff trained in each school. As part of the Health and Safety component of the Professional Activity Day in November, Principals were provided with material to help all staff members understand the role that they play in Violent Threat Risk Assessment, even if they are not part of the VTRA team.

Traumatic Event Systems Training:

In February, members of Senior Administration, all principals, Social Workers, Communication Officers, Health and Safety Officer and some vice-principals received Traumatic Event Systems Training with Kevin Cameron. Participants learned how to support students, staff and parents following a traumatic event. Members of the Crisis/Trauma Response Steering Committee will use the materials provided to revise our Critical Incident Response Handbook.

Anti-Oppression Training:

As part of our Safe Schools Strategic plan and our Equity plan, all administrators participated in a one-day Anti-Oppression training. This training served as continuation of the Equity Course that all administrators have taken.

Restorative Practices

This year we continued our Durham Catholic District School Board training on Restorative Practices. Day one of training is Developing a Restorative Mindset: Theory into Practice and day two of training is Social Architecture: Circles in the Classroom. The training was offered to school teams so that the team can collaborate on their learning in between sessions.

School and Inclusive Schools Survey

Every two years, the Ministry of Education requires all schools in the province to implement a School Climate Survey with all students in grades 4 to 8 and a minimum of 25% of students in grade 9 to 12. The purpose of the Safe and Inclusive School Survey is to gather data on how safe and accepted students feel at their school. The data can then be utilized by the Safe School Team to help inform the school's Bullying Prevention and Intervention Plan, Mental Health Action Plan and the Catholic, Community, Culture and Caring School Improvement Goal.

The staff and student survey was completed during the Bullying Prevention Week in November. The parent survey was available via a banner on the Board website for almost a month. This year, all schools were asked to aim for 100% participate in grade 4 to 12. As a result, we had significantly more secondary school students participate in the survey.

In general terms, we saw a consistency in patterns since the last Safe and Inclusive School Survey with steady improvements in all areas. For example, verbal bullying continued to be the most prevalent type of bullying that students experienced, with 37% of students reporting that they had experienced this type of bullying since September. In 2014, 42% of students reported that they had experienced this type of bullying in the same time frame.

One significant data point was the number of students who were unaware of the anonymous reporting tool "Report It". This was consistent across most schools and schools were able to take action to ensure that students knew how to access this reporting mechanism.

RATIONALE

Overview

In January 2016 the Board of Trustees received and approved the 2016-2020 Long Term Accommodation Plan (LTAP) following a review of existing and projected enrolments, the development of guiding principles and undertaking a number of meetings and consultations with the public.

Re: Long Term Accommodation Plan – 2017 to 2021

Date: February 27, 2017

The Board's LTAP summarizes the Board's planned activities with respect to site acquisition and disposition, planned new capital construction, major program or boundary changes, and proposed accommodation reviews to be conducted as outlined in Policy PO-430 Pupil Accommodation Review.

The LTAP document is an annual report that addresses actions to be undertaken by the Board over a 5 year period. The LTAP establishes a set of guiding principles that all proposed actions must be viewed against, and presents a series of actions to be committed to, by the Board in the first year of the plan (subject to any Board of Trustee approval required in the case of a pupil accommodation review). The list of additional actions proposed in years 2-5 of the plan are to be approved by the Board of Trustees in subsequent years. Events which are subject to Ministry approval are identified as such, with the desired timelines attached. It is recognized that actions that are dependent on Ministry approvals and funding may not always occur in the year(s) proposed and may be subject to reevaluation based on funding, approvals or both.

For each subsequently developed LTAP, a new year with appropriate actions will be added to the plan. Completed projects will be removed from the plan as new projects and modified projects are added on an annual basis. Some projects listed by year in years 2-5 may move as a result of changes in enrolment, program directions and utilization.

The LTAP reflects the current enrolment and capacity of the Board, the projected number of students as contained in the Board's Accommodation Utilization Report as submitted on December 19, 2016, all Ministry of Education Capital projects which have been approved, and any funding requests which have been, or will be submitted through the Capital Planning process to the Ministry of Education. The LTAP addresses required property acquisitions and dispositions to fund some of the actions within the plan.

Within this document there are three sections:

- Appendix 1 contains detailed proposals with respect to the actions to be approved by the Board of Trustees for 2017;
- Appendix 2 contains a review of all data and actions organized on a Family of Schools basis;
- Appendix 3 contains a list of all actions from the previous LTAP that have been completed.

Guiding Principles

As a result of meetings with staff, principals and senior administration, and guided by previous studies and actions undertaken by the Board over the last two years, the development of the LTAP reflects a series of important guiding principles that provide a framework to assess the proposed actions. - 4 involve community engagement and consultation;
- 5 be based on enrolment projections which are formulated using current planning methodologies and demographic information;
- 6 consider the requirements of the Accessibility for Ontarians with Disabilities Act;
- 7 maximize the efficiency and effectiveness of Board facilities, including technology modernization.
- 8 support a range of program models and opportunities in elementary, secondary, and continuing education;
- 9 consider partnership and community hub opportunities and;
- 10 consider the impact on student transportation.

Proposed Actions by Year

The following provides a series of anticipated accommodation actions to be undertaken by the Board from 2017 to 2021 inclusive. Community Partnership and Co-Build Opportunities

Developing cooperative and collaborative facility partnerships enables the Board to improve utilization of school buildings, reduce facility costs and improve educational opportunities as well as demonstrating a willingness to collaborate with designated Community partners.

Partnerships may involve co-building new facilities, or leases, licenses and joint use agreements to utilize part of an existing school or administrative facility specifically during school hours. Where a partnership is appropriate for the school setting and where it enhances student achievement, the Board is receptive to sharing facilities for the use of unoccupied space in existing schools and administration facilities. All planned new schools within the plan, which are yet to be approved and funded by the Ministry of Education, can be considered for potential partnership in accordance with the provisions of the Boards Community Planning and Partnership Policy.

Board staff will work with the Ministry of Education and work within the Community Planning and Partnership Guidelines and Policies for establishing Community Hubs in schools.

NEXT STEP

Pending approval of the LTAP by the Board of Trustees, public information sessions and consultations will be organized by Board staff. A detailed communication plan will be executed so that all members of the Durham Catholic District School Board community will be made aware of the dates and locations to maximize participation in the process.

APPENDIX 1: DETAILED REVIEW OF ACTIONS PLANNED FOR 2017

Open the new 6 classroom addition and major renovations at St. James Catholic School (now under construction);

The Board received approval from the Ministry of Education to construct a 6 classroom addition and undertake renovations at St James Catholic School in 2015. The project started construction in July 2016. Students will move into the addition in March 2017. All other renovations and site works will be completed prior to September 2017.

Open the new Child Care Centre at St. Josephine Bakhita Catholic School (now under construction);

The Board received approval from the Ministry of Education to construct a child care centre at St Josephine Bakhita Catholic School in 2015. The project started construction in August 2016. The new Child Care Centre will be completed for April 2017. All related site works addition will be completed prior to September 2017.

Initiate a boundary change between All Saints Catholic Secondary School and Father Leo J Austin Catholic Secondary School

The Board undertook the review of programs and service delivery models for the Catholic Secondary Schools in the Town of Whitby during 2016. The final report was brought to the Board of Trustees and approved on January 30, 2017. All Saints Catholic Secondary School and Father Leo J Austin Catholic Secondary School have boundaries which include a portion of both the St. Theresa Catholic School boundary and the St. Matthew the Evangelist Catholic School boundary. The intention of the boundary change will be to have the secondary school boundaries match the elementary school boundaries, and have all students directed from both elementary schools to Father Leo J Austin Catholic Secondary School. It is intended that a boundary change process will be initiated in the spring of 2017 in accordance with Board Policy PO-415.

Initiate a boundary change between St. Matthew the Evangelist CS and St. Luke the Evangelist CS

The Board undertook the review of programs and service delivery models for the Catholic Secondary Schools in the Town of Whitby during 2016. The final report was brought to the Board of Trustees and approved on January 30, 2017. As a result of the Whitby Secondary Study, the growth area north of Taunton Road, and west of Cochrane Street in the St. Matthew the Evangelist Catholic School boundary is planned to be reassigned to the St. Luke the Evangelist Catholic School boundary. It is intended that a boundary change process will be initiated in the spring of 2017 in accordance with Board Policy PO-415.

APPENDX 1-2

Initiate a boundary change between Father Leo J Austin Catholic Secondary School and Monsignor Paul Dwyer Catholic High School

The Board undertook the review of programs and service delivery models for the Catholic Secondary Schools in the Town of Whitby during 2016. The final report was brought to the Board of Trustees and approved on January 30, 2017. As a result of the Whitby Secondary Study, the proposed boundary change would direct students from the French Immersion programs at St. Thomas Aquinas Catholic School, St. Christopher Catholic School and St. Kateri Tekakwitha Catholic School to attend Monsignor Paul Dwyer Catholic High School for French Immersion programming. It is intended that a boundary change process will be initiated in the spring of 2017 in accordance with Board Policy PO-415.

Complete the disposition of the former St. Gertrude Catholic School;

The Board declared the former St. Gertrude Catholic School surplus to its needs in 2015 and has placed the property on the open market for sale. It is anticipated that a purchaser will be found and that the sale will be finalized during 2017.

Complete the disposition of the former Immaculate Conception Catholic School;

The Board completed The Port Perry Catholic Elementary School Accommodation Review in May 2016. In June 2016, the former Immaculate Conception Catholic School closed. In October 2016, the Board declared the school surplus to its needs in accordance with Ontario Regulation 444/98. The Board is undertaking the disposition of the former school building and lands during 2017.

Open the new Adult and Continuing Education program site in Oshawa;

The Board has entered into an agreement to open a new Adult and Continuing Education site at 850 King Street West in the City of Oshawa. This new site is under construction by the owner and will be ready for September 2017 occupancy. The new site replaces the existing site located at the former St. Gertrude Catholic School in Oshawa.

Examine potential locations for a North Durham Continuing and Adult Education program;

Board staff will assess the potential to locate one or more Adult and Continuing Education programs in facilities owned or leased by the Board in the northern three municipalities within Durham Region.

APPENDIX 1-3

Determine potential location(s) for the Board's Alternative Education programs;

The leases for the Board's existing Alternative Education program locations are due to expire by August 2018. As such the Board needs to determine if the existing locations supporting the Alternative Education programs are still viable. If the Board needs to relocate one or more programs, suitable locations need to be found for a September 2018 start up.

Open the new hub space for the Community Innovation Lab at Monsignor Paul Dwyer Catholic High School

The Community Innovation Lab has developed a partnership with the Durham Catholic District School Board to utilize vacant classroom spaces at Monsignor Paul Dwyer Catholic High School. This partnership will reduce the capacity of the school and will add a dynamic partner to the Board

Purchase the Unnamed Ajax Audley Catholic Elementary School site;

In November 2016, the Board authorized staff to begin to acquire the Unnamed Audley Road Catholic Elementary School site which is located south of Rossland Road and west of Audley Road in the Town of Ajax. This future Catholic Elementary school site gives the Board the ability to construct additional pupil places to serve students in the Town of Ajax at a point in the future, subject to Ministry approval and funding.

Review the boundary between Father Joseph Venini Catholic School and the Unnamed North Oshawa Catholic School;

The Board must review the boundary between the existing Father Joseph Venini Catholic School and the Unnamed North Oshawa Catholic School in advance of its opening in September 2019. It is intended that a boundary change process will be initiated in the fall of 2017 in accordance with Board Policy PO-415.

Request Ministry funding approval for the construction of the Unnamed Seaton #1 Catholic Elementary School;

The Board requested Ministry of Education funding and approvals to construct a new 611 pupil place Catholic Elementary school to serve students generated from the new Seaton Community located in the City of Pickering. This new school once constructed will accommodate students generated from this new 70,000 person community. Construction and occupancy of new homes is slated to begin in late 2017. This project has previously been submitted to the Ministry of Education.

APPENDIX 1-4

Request Ministry funding approval for the replacement of St. Marguerite D'Youville Catholic School;

The Board will submit its request to replace St. Marguerite D'Youville Catholic School to the Ministry of Education as it relates to the type of construction and the facility condition. Originally constructed using relocatable classroom modules, the school and many building systems are reaching the end of their theoretical life cycle. As such the Board is requesting funding to construct a permanent school building and demolish the existing school building.

Request Ministry funding approval for the construction of the replacement of Monsignor Paul Dwyer Catholic High School

A new Catholic Secondary School site is required to facilitate the relocation and reconstruction of the existing Monsignor Paul Dwyer Catholic High School for 2019. Because the requirements for this school site are not in the Board's 2014 Educational Development Charges (EDC) Background Study, the Board is seeking approval and funding from the Ministry of Education to purchase the site. The site is located on the east side of Harmony Road, North of Taunton Road adjacent to the City of Oshawa's Legends Centre. This project has previously been submitted to the Ministry of Education in 2016 for approval.

Request Ministry funding to construct the Unnamed Brooklin Catholic Secondary School

The Board will submit its request to the Ministry of Education to fund construction of a new Grade 7-12 Catholic Secondary School to serve students located within the Brooklin community. The Board currently operates three Catholic Elementary Schools in the Brooklin Urban Area and has additional designated lands for three future Catholic Elementary schools in the expansion areas of the Brooklin Secondary Plan.



This report summarizes the requirements to develop school boundaries in accordance with Board Policy PO-415 and proposes that students from the new development area in the St. Matthew the Evangelist Catholic School boundary be directed to attend St. Luke the Evangelist Catholic School for Grades JK-8 in the Regular track (English) program.

Boundary Policy

In accordance with Board Policy PO-415 School Boundary, a proposed school boundary is developed for each Catholic Elementary and Secondary School located within the Board's jurisdiction. The development of boundaries is undertaken to create neighbourhood or community schools. The boundary of each school should be of a sufficient size to sustain the long-term operation of the school at a full or near full capacity level.

Staff is required, through Policy, to report to the Board of Trustees with respect to the proposed boundaries. The Board of Trustees approves "In Principle" so that when the community consultation process commences, the affected schools will have a draft set of boundaries to work from, and provide comments on.

Following the meetings with the affected communities, and based on input from these communities, a final report on the proposed set boundaries is brought to the Board of Trustees for approval.

Boundary Review Process

ANALYSIS

Existing Enrolment and Boundaries

At present the boundary for St. Matthew the Evangelist Catholic School includes the lands north of Rossland Road between Garden Street and Brock Street, the lands south of Rossland Road between Brock Street and Pringle Creek, and a large future development area between Taunton Road and Lyndebrook Road west of Lynde Creek. While there are students in most portions of the current St. Matthew the Evangelist Catholic School boundary, there are almost no students in the rural homes along the boundary roads. Appendix 1: indicates the existing boundaries for St. Matthew the Evangelist Catholic School and St. Luke the Evangelist Catholic School boundary for Grades 9-12. The proposal to change the development area to attend St. Luke the Evangelist Catholic School aligns the elementary and secondary school boundaries. The current projected enrolment for the two schools is outlined on table 1 below.

Proposed Development Applications

The development area which is to be affected by the proposed boundary change is located within the West Whitby secondary planning area and contains a total of 1,283 units of housing to be developed over a multi –year period. The first new houses are anticipated to be occupied in 2018. Table 1 below indicates the current number of houses by type for the two plans.

Proposed Boundary and Enrolment Impacts

The proposed boundary change will direct all students from the new development areas north of Taunton Road and west of Lynde Creek to attend St. Luke the Evangelist Catholic School for Grades JK-8. The timing of the boundary change will eliminate the need for students to switch schools since the development will start generating homes and potentially students in 2018. It is intended that portables will be required at St. Luke the Evangelist Catholic School by 2022, and that there will be enough students within the West Whitby planning area by 2026 to generate a new Catholic elementary school to serve this population. Notwithstanding the proposed boundary change, St. Matthew the Evangelist Catholic School will operate at or near capacity over the same period. 

Student transportation under the existing and proposed boundaries will be unaffected due to the distance and required crossing of Taunton Road to each school from the new development areas.


NEXT STEPS

ANALYSIS

Existing Enrolment and Boundaries

Within the Durham Catholic District School Board each secondary school is served by a series of feeder schools for the Regular Track (English) program, and in schools like Father Leo J. Austin Catholic Secondary School by a series of French Immersion feeder schools. At present All Saints Catholic Secondary School and Father Leo J. Austin Catholic Secondary School each take in a portion of the St. Theresa Catholic School boundary and the St. Matthew the Evangelist Catholic School boundary. As a result students are directed to attend two different secondary schools from these two feeder schools. In many cases students have to apply to attend out-of-area to attend a Catholic Secondary School with their grade 8 classmates. Appendix 1: indicates the existing boundaries for All Saints Catholic Secondary School and Father Leo J. Austin Catholic Secondary School.

Impact of Boundary Changes

A review of the current Grade 9 students from St. Theresa Catholic School determined that of the 25 students, 15 students from the Father Leo J. Austin Catholic Secondary School portion of the boundary, and 4 students from the All Saints Catholic Secondary School portion of the boundary attend Father Leo J. Austin Catholic Secondary School, while 6 students from the All Saints Catholic Secondary School portion of the boundary attend Father Leo J. Austin Catholic Secondary School, while 6 students from the All Saints Catholic Secondary School portion of the boundary attend Father Leo J. Austin Catholic Secondary School, while 6 students from the All Saints Catholic Secondary School.

Similarly, for the St. Matthew the Evangelist Catholic School boundary there are 36 students from the Father Leo J. Austin Catholic Secondary School portion of the boundary, and 4 students from the All Saints Catholic Secondary School portion of the boundary that attend Father Leo J. Austin Catholic Secondary School. Tables 1 and 2 below summarize the number of students who attend the schools from within their respective boundaries.

Proposed Boundaries and Implementation

The proposed boundary change will direct all students from St. Theresa Catholic School and St. Matthew the Evangelist Catholic School to attend Father Leo J. Austin Catholic Secondary School for grades 9-12 for the Regular Track program. The boundaries for French Immersion students attending Father Leo J. Austin Catholic Secondary School are addressed in a separate report.

Because of the very small number of students to be potentially affected, there will be no significant change in the projected numbers of students to attend Father Leo J. Austin Catholic Secondary School for grades 9-12 for the Regular Track program since many students within the All Saints portion of the boundary now attend the school on an out-of-area basis.





Existing Enrolment and Boundaries

At present the French Immersion boundary for Father Leo J. Austin Catholic Secondary school incorporates students from both Oshawa and Whitby and includes students from the following feeder schools. The table below indicates the current grade range and the year the program was started:

It has been the Board's intention through the review of French Immersion programs to start an Oshawa French Immersion program at the point where it would be of a sufficient size to sustain the long-term operation of the program.

As of September 2016, only four of the seven feeder schools have a Grade 1-8 French Immersion or Grade 4-8 Extended French program. In 2022 all seven feeder schools will have graduating grade 8's.

Initially, the program to be located at Monsignor Paul Dwyer Catholic High School will have one Grade 9 class of 15 students for September 2018. By September 2020, there will be 38 Grade 9 students from two feeder schools (St. Thomas Aquinas Catholic School and St. Christopher Catholic School) and an estimated 70 students in the program in Grades 9-11 assuming that all eligible students enter the program and remain in the program over the three year period.

Beyond 2020 the program will grow at a much quicker rate due to larger class sizes in the program in the feeder schools, and with the addition of students from the St. Kateri Tekakwitha Catholic School program in 2022. By 2026 it is estimated that 340 students will be in the program in Grades 9-12.

Proposed Boundaries

The proposed French Immersion boundary for the Monsignor Paul Dwyer Catholic High School will include students from the following elementary French Immersion programs:

- St. Thomas Aquinas Catholic School
- St. Christopher Catholic School
- St. Kateri Tekakwitha Catholic School

The boundaries for the three programs extend north from Lake Ontario in the south to the boundary between Oshawa and the township of Scugog in the north. The east and west boundaries match the City of Oshawa boundary.

Implementation

It is intended that all grade 9 students in French Immersion programs from the Oshawa feeder schools would attend the new Monsignor Paul Dwyer Catholic High School program once the new boundary is implemented. The new program would be phased in a grade at a time so that after 4 years there would be a complete Grade 9-12 program.

Students within the new boundary who are currently attending Father Leo J. Austin Catholic Secondary School in Grades 9-12 would be allowed to finish their program at the school in-so-far as there would not be a program at Monsignor Paul Dwyer Catholic High School for those students in those grades.


Once the new program is fully phased in for Grades 9-12 it is assumed that students within the Monsignor Paul Dwyer Catholic High School boundary will attend the school for the French Immersion program. In accordance with Board Policy all students who require student transportation will have it provided within the Board's ride time parameters to Monsignor Paul Dwyer Catholic High School.






Durham Catholic District School Board Catholic Secondary School French Immersion Boundary Whitby and Oshawa - Current Boundary
