g.1 SAFE AND CARING SCHOOLS UPDATE

Superintendent of Education, Janine Bowyer, shared an overview of the Board's Safe and Caring Schools initiatives. She reviewed the Board's Bullying Prevention and Intervention activities and acknowledged many students who played a key role throughout the year. Superintendent Bowyer recognized students whose work was selected in the multi-media contest launched in September 2016 along the theme of Kindness is My Superpower. Superintendent Bowyer highlighted the work taking place in Safe and Accepting Schools including:

- Safe and Caring Schools Week; Bullying Prevention and Intervention Week; and Stand Up to Bullying Week
- Implementation of the Police/Board Protocol in September 2016
- Violent Threat Risk Assessment (VTRA) training
- Traumatic Event System (TES) training
- School Climate Surveys
- Restorative practices leadership team development
- Teaching and Reinforcing Pro-Social Skills

g.2 LONG TERM ACCOMMODATION PLAN 2017-2021

Superintendent of Facilities Services, Bob Camozzi and Lewis Morgulis, Manager of Planning, Admissions and Partnerships presented the five-year Long-Term Accommodation Plan (LTAP). The Report included the guiding principles for the LTAP; the review of actions for each year, and the proposed actions for 2017-2021. Trustee Forster asked about the context of the Ajax review in 2017. Director O'Brien advised that the Board will review a jurisdiction each year and Ajax will be reviewed in 2017-2018. Trustee Corless inquired about a boundary review for a small section of Oshawa feeding into Msgr. John Pereyma Catholic Secondary School. Director O'Brien indicated that a future Oshawa study would review the boundary, program and services. Superintendent Camozzi will bring an update to a future Board meeting pertaining to numbers of students currently feeding into Msgr. John Pereyma Catholic Secondary School. <u>Item i.1</u> Durham Catholic Autism Resource Team H. Killoran/K. Kenney

Helen Killoran and Kara Kenney, members of our Durham Catholic Autism Resource Team (DCART), presented on courses we offer to our educators on the principles of ABA. Training is offered to Educational Assistants, Teachers and Early Childhood Educators. This supports the implementation of PPM 140 which indicates that strategies based on Applied Behaviour Analysis (ABA) are used with students with Autism Spectrum Disorder (ASD) as needed. Four major components of PPM 140 include: Reinforcement, Data Collection, Generalization and Individualized Programming. Four courses were developed based on the components of PPM 140

This year, an additional course on Functional Assessment and Intervention was added. This course is open to educators involved with either the DCART and BRT. This 4-week course was developed to build capacity within the school teams to apply the knowledge to other future students.

Item m.1 Coordinator's Report – C. Plommer

On February 16th, the Assistive Technology team hosted their final 'Students with Assistive Technology Transition Trip' at Monsignor John Pereyma CSS. The students who use Assistive Technology from the local elementary schools experienced what Grade 7 would be like. They participated in Mr. Stokes' Science class with their technology and received extensive training on One Note. The student experienced what it is like to eat in the school cafeteria and they learned how A.T. is supported with Mr. Porco, the Program Support Teacher for the Grade 7 and 8s. After surveying the students about their experience, feedback included "I now know how to use my computer in my new school."

As part of the DCDSB Renewed Math Strategy, our Student Services Department continues to build capacity with our program support teachers at the elementary and secondary levels. At our most recent capacity session held on February 24th, both the student services coordinators and staff from our psychology department helped teachers to understand the strengths and needs that make up learning profiles of students with learning disabilities and what are the best strategies to put in place to help them to achieve and reach their full potential in mathematics.

On March 28th, we will be inviting interested teachers to come to our "So You Want to be a PST" presentation. This presentation is given with the hope to encourage qualified teachers to apply to this most rewarding role as the Special Education expert in their school.

In April, Student Services Coordinators will be embarking on our review of the needs across our system to prepare for the upcoming 2017-18 school year.

<u>Item m.2</u> <u>Mental Health Leader's Report – D. Mullane</u>

On January 19 & 27, we offered a **Mental Health First Aid** session and opened it up to all staff. In addition to teachers and EAs, several school secretaries also participated. Our next MHFA session will take place on March 31 and April 6.

<u>Item m.2</u> <u>Mental Health Leader's Report – D. Mullane</u> (Cont'd)

Two **safeTALK** sessions were provided for EAs on January 20 (Elementary) and January 31 (Secondary).

The TAMI Intermediate Summit took place on January 24 at Ontario Shores Centre for Mental Health Sciences. Four student delegates and one teacher attended from eight DCDSB schools. A second date has been added in April, due to high demand.

January 25 was Bell Let's Talk Day. Administrators were provided with lapel pins, and schools were encouraged to print off Bell Let's Talk stickers and promote the event.

A Sharing of Excellence workshop on Building Personal Resiliency was also offered on January 25th.

A quick update on the Mindfulness Fundamentals course that was mentioned at the December meeting. In total 59 staff (from 11 schools) took part in the course. A follow-up event took place this afternoon. We're excited to see the trickle-down effect in schools as educators begin to incorporate these skills for themselves and with their students.

We've been collaborating for several months with the Durham Region Health Department on a document for parents to support their teens as they transition to high school. This resource, <u>Teens Can Be Resilient...in High School</u>, a <u>Parent's Guide</u>, is now available in print and online to view and order at <u>durham.ca/mentalhealth</u>. Topics covered in this resource include: understanding mental health and resiliency; fostering everyday skills for living in teens; peer relationships; bullying; dating; risk-taking and substance use; and supporting teens that are having difficulty coping. (SEAC members were provided with a copy of this guide).

Finally, our parent conference was a huge success. Thanks to all community partners who provided workshops and set-up displays.

<u>Item m.3</u> <u>Superintendent's Report - J. Bowyer</u>

Congratulations to Diane Mullane and SEAC on their "Parents as Partners" evening last week. They had approximately 100 people in attendance and significant positive feedback about the keynote and various speakers. They keynote speaker was so well received that we have booked her for our Board wide PA day in April.

We applied for After School Program to Support Students with Autism – specialized funding provided by the Ministry of Education. Beginning after the March Break, we will be offering after school programs in five sites, serving approximately 45 students and their parents. Rationale

Attached is the Regional Bell Time Study prepared by Durham Student Transportation Services (DSTS). The study was reviewed by the DSTS Governance Committee in November 2016. The report and related recommendations were approved, in-principle, by the respective member Boards in January 2017, subject to public consultation in February 2017. The Governance Committee reviewed input received during the consultation process at its most recent meeting on February 28, 2017. Following discussion, the Governance Committee passed a motion recommending approval of the DSTS Regional Bell Time Study, effective September 2017, by the member Boards at their respective Board meetings in March 2017.

Background

DSTS operates under parameters as determined by the member Boards and the DSTS Governance Committee. Such factors include walk distance (eligibility, home to stop), ride times (average, one-way), program (French, Special Education, Alternative Education), school location, school boundaries, supervision windows (as per collective agreements) and school start times. Each of these factors has a direct influence on the efficiency and number of buses required to provide transportation in accordance with the Transportation Policy and Procedures.

From a transportation perspective one of the key performance metrics is tiering of buses wherein a particular bus can be used for multiple routes within the available time the bus can be on the road under contract (typically 90 minutes in the morning and 90 minutes after school). Inherently the more routes a bus can do the more students it can transport within the allotted time.

Coordinated school start times within neighbouring communities significantly enhances DSTS ability to tier buses and to maximize ridership thereby minimizing the number of buses required. The last time a system bell time review was undertaken was ten years ago in 2006/2007. Much has changed within the Region over the past decade including demographic shift, traffic intensification and the creation of new communities. As such, the DSTS Governance Committee commissioned a Regional Bell Time Study during the 2015/2016 school year in order to assess potential opportunities for maximizing efficiency and effectiveness and consequently minimizing the number of buses required.

Recommendations

Staff is pleased to note that the attached report presents recommendations that would reduce the required number of buses by 48. This represents an annual combined savings of approximately \$1.92 million to the member Boards of which DCDSB would see approximately one-third (\$640,000) of the savings based on proportionate ridership. As discussed at the January 19, 2017 Finance Committee meeting, transportation is a non-classroom expenditure. As such, any proposed savings would be of great assistance in maintaining a balanced budget and advancing the Board's Strategic Plan.

In order to achieve the increased efficiency through more effective tiering of buses, DSTS is recommending bell time changes in 38 of 171 schools. Specifically, 27 of the 38 schools would see changes of 10 minutes or less and 11 schools would see changes of 15 minutes or greater. From a DCDSB perspective 10 schools are recommended for a bell time change of which 9 are 10 minutes or less and only 1 school has a proposed change of 15 minutes or greater.

Consultation

At the November 2016 meeting the DSTS Governance Committee approved the recommended changes, subject to a joint public consultation process and final approval of the member Boards. The respective Boards approved the recommended changes, inprinciple, in January 2017, and provided their support to engage in the joint public consultation process. Public meetings were held on February 13th (Notre Dame CSS), February 14th (All Saints CSS) and February 15th (Port Perry HS), wherein staff and Trustees provided information and received direct feedback with respect to the proposed changes. There was a turnout of approximately 100 parents across the three sessions, with the majority being from DDSB schools with the larger proposed bell time changes.

In addition to the open house sessions, a dedicated email and phone line was made available to parents to provide their input. DSTS received a total of 305 comments from a total population of 24,537 students from the 38 schools who have recommended bell time changes. Of the 305 comments, 8 were from DCDSB parents, with no more than 3 being from any one school.

There was also discussion at the Catholic School Council meeting at St. Thomas Aquinas CS on February 6, 2017, regarding the proposed change of 25 minutes for their school community. In the case of this particular school, there were legacy conditions that precipitated the current bell times which no longer exist. Furthermore, it is anticipated that the proposed bell time change may actually reduce ride times at this particular school given the ability to balance out some of the current routes as a result of increased efficiency and tiering opportunities. In addition, staff are exploring potential before and after school programming opportunities in conjunction with the proposed bell time change.

Conclusion

Staff is recommending approval of the DSTS Regional Bell Time Study and related recommendations, with the proposed bell time changes taking effect September 2017.

A review of the Ajax, Pickering, Uxbridge, Whitby, Oshawa, Scugog and Brock area school bell times has been conducted. Current and proposed bell times have been provided in separate sections within this document for the areas listed above.


Utilizing the proposed bell times for the areas listed (based on 2015-16 rider data) would result in the following:

- Overall potential savings/reduction of 48 buses
- reduced buses achieved primarily through improved tiering opportunities based on proposed time changes which enables different pairing of schools in many cases and/or reduction in slack time resulting in the ability to facilitate more Tier 2 and Tier 3 routes and the ability to combine runs
- resolution of crossing guard timing issue in North Oshawa (Coldstream and Clearbrook)
- opportunity to address community concerns in Uxbridge with regard to traffic congestion and student safety as well as reduced number of buses going into the areas of concern
- resolution of crossing guard timing issue in Whitby (Dryden and Waller)


Potential Savings by Area (utilizing approx. cost of \$40,000 per bus)




Number of Buses Utilized




Potential Buses Saved by Area






AJAX BELL TIME CHANGES

AJAX - Other Considerations:

- The reduction of buses is based on the current transportation policy and rider data.
- In the event of a DDSB policy change regarding secondary student eligibility for transportation moving from a distance of more than 4.0 km to more than 3.2 km, this change would potentially require an additional 14 runs (7 am/7pm). Subject to implementing the draft model and adjusting current runs we could facilitate 12 runs (6am/6pm) which would result in the need for one additional bus.
- In the event of a DDSB policy change regarding transportation eligibility of JK/SK students for transportation when attending a single track French Immersion school where a sibling is currently attending and is eligible for transportation, this will require one bus to accommodate within the proposed model, however this bus could be tiered with the additional bus required for the Secondary 3.2 (if policy change occurs), which would result in no additional buses required for this initiative.




WHITBY BELL TIME CHANGES






OSHAWA BELL TIME CHANGES



Utilizing the proposed Pickering bell times (based on 2015-16 rider data) will result in the following:

- savings/reduction of 9 buses (15%) bus utilization (70 passenger) is currently 61 buses
 new draft model would utilize 52 buses
- reduced buses achieved primarily through improved tiering opportunities based on proposed time changes, which enables different pairing of schools in many cases and/or reduction in slack time, which resulted in the ability to facilitate more Tier 2 and Tier 3 routes
- 25 Pickering schools 6 DCDSB and 19 DDSB
- 6 (out of 25) Pickering schools with proposed bell time changes (see chart below)
 - √ 3 schools proposed 10 minutes earlier dismissal
 - √ 1 school proposed 10 minutes later
 - √ 1 school proposed 20 minutes earlier
 - √ 1 school proposed 25 minutes later
 - ✓ 24% of schools have proposed bell time changes (with 67% of those schools in the ten minute or less category)
- Previously 87% of routes with multiple schools new model has 100%
- Previously 20% of routes with single runs new model would reduce this to 7%
- Ride times will remain primarily the same (see chart)

PICKERING - Other Considerations:

- The reduction of buses is based on the current transportation policy and rider data.
- In the event of a DDSB policy change regarding secondary student eligibility for transportation moving from a distance of more than 4.0 km to more than 3.2 km, this change would potentially require an additional 10 runs (5 am/5pm). Subject to implementing the draft model and adjusting current runs we could facilitate 6 runs (3am/3pm) which would result in the need for two additional buses.
- In the event of a DDSB policy change regarding transportation eligibility of JK/SK students for transportation when attending a single track French Immersion school where a sibling is currently attending and is eligible for transportation, this will require two buses to accommodate within the proposed model.

Brock Area Schools Bell Time Review - Draft Model

There are no bell time changes proposed for Brock Area schools.

Utilizing the proposed bell times will result in the following:

- saving of 5 buses overall
- 1 less bus going into Prince Albert Public School
- 1 additional bus going into S.A. Cawker
- · remaining schools have same amount of runs

The saving of 5 buses is achieved through better tiering opportunities as a result of bell time changes. The tiering opportunities enables elimination of buses but not necessarily elimination of runs as demonstrated in the chart above. Some of the runs were blended and others tiered.

With multiple programs and language tracks at R.H. Cornish PS and Port Perry HS, although extensive review took place, due to the distance, ride times, and high proportion of runs blended, the number of buses going into these schools has not changed. Some runs which were not previously tiered are now tiered, which has contributed to the overall savings of five buses.


- saving of 5 buses overall
- 4 less buses going into Joseph Gould PS
- 3 less buses going into Uxbridge SS
- 3 more buses going into Uxbridge PS
- 2 more buses going into St. Joseph Uxbridge CS

The saving of 5 buses is achieved through different tiering opportunities as a result of bell time changes. The tiering opportunities enables elimination of buses but not necessarily elimination of runs as demonstrated in the chart above. Some of the runs were blended and others tiered. In some cases the route changes enabled a reduction in the number of buses going into the schools, however, in other situations the number of buses going into the schools remained the same or increased, even though there was an overall savings of buses.


With multiple programs and language tracks at Uxbridge Secondary School, Uxbridge Public School and St. Joseph Catholic School, although extensive review took place, due to the distance, ride times, and high proportion of runs blended, there were some adjustments in the number of buses going into these schools, however, they continue to have a high volume of busing and required buses. Some runs which were not previously tiered are now tiered, which has contributed to the overall savings of five buses.

In order to facilitate the opportunity of bus savings as well as address school community and concerns of the town with regard to traffic congestion and student safety, the school hours of Joseph Gould PS could be adjusted as indicated in the chart above. In making the adjustments, DSTS would be able to reduce the actual number of buses going into Joseph Gould PS as well as Uxbridge Secondary School. With the reduced number of buses going into these two schools, in addition to the change in school hours, there would be a significant improvement with respect to traffic congestion within the neighbourhood.


BROCK/SCUGOG/UXBRIDGE COMBINED - BELL TIME CHANGES

PURPOSE

In accordance with provisions of the Education Act a Board must charge tuition fees to foreign student to cover the cost of education. During the 2016/17 school year, the Board had 26 elementary and secondary foreign students. The purpose of this report is to review the current fee amount and recommend Foreign Student Fees for the 2017/2018 school year.

RATIONALE

At the regular Board meeting held on March 29, 2016 the Board of Trustees approved a foreign student fee of \$12,200.00 for elementary students and \$13,300.00 for secondary students. In addition, the Board charges a one-time registration fee amount of \$250.00 for each foreign student. This fee amount has been in use since 2015.

The fees include a \$1,500.00 ESL component which the parents/guardians are required to pay. If the school determines that the student did not require ESL programme the \$1,500.00 will be refunded to the parent/guardian.

In determining an appropriate fee amount staff reviewed the fees charged to international students at six surrounding school boards. The table below indicates the fee amounts for elementary and secondary school students.

The Durham Catholic District School Board has not increased its Foreign Student Fees for a number of years. Staff recommends that the fees be increased to \$12,500 for elementary students and \$13,750.00 for secondary students for the 2017/2018 school year. This fee amount is consistent with the tuition charged by neighboring boards and covers the cost of education as required by the Act.
