R. Putnam reviewed the current year budget information as contained in the 2019/2020 Revised Estimates report which was approved in December 2019 in order to provide an initial foundation for the upcoming 2020/2021 budget process. Subject: 2020/2021 Estimates – System Investments

Recommendation

"THAT the Finance Committee receive as information an overview of proposed system investments to be included in the 2020/2021 Estimates."

Rationale

As indicated in the Budget Update report at the April 27, 2020 Board meeting, the typical budget process has been impacted due to the closure of the education system and the Province's focus on the immediacy of the current pandemic situation. In particular, Boards are awaiting the release of Ministry funding information and financial package in order to calculate next year's grants and to complete the budget booklet. Boards have been advised that the Ministry intends to maintain stable funding from this year to next so that local budget planning can continue. In addition, recent Provincial agreements with the various education sector unions have provided a number of system investments that Boards are able to incorporate into their planning for next year. Senior Administration has engaged in a number of discussions in recent weeks and has developed a balanced budget plan that reflects new system investments and advances local strategic priorities. Staff will present the budget plan to the Finance Committee on May 4th with a focus on changes from this year to next and an emphasis on areas of new and/or increased investment. Staff intends to present a draft budget booklet to the Finance Committee on June 8th and to seek Trustee approval at the June 15th Board meeting provided the funding information is released in time. An update will be provided at the May 25th Board meeting as to the status of the information and budget timelines.
